SAILING INSTRUCTIONS AMENDMENT No.1

Delete SI17.2a.

Add to the last sentence of Q5.4:
"or SI20.1".

Delete old Q5.1.

Add new Q5.1:

"No proceedings of any kind may be taken in any relation to any action or non-action by an umpire."

Add new Q4.4:

"When the umpire(s) calling the incident, together with at least one other umpire, decide that a boat has broken rule 14 and damage resulted, they may impose a points-penalty without a hearing. The competitor shall be informed of the penalty as soon as practicable and, at the time being so informed, may request a hearing. The protest committee shall then proceed under Q5.3. Any penalty decided by the protest committee may be more than the penalty imposed by the umpires. When the umpires decide that a penalty greater than one point is appropriate, they shall act under Q4.3."
