1.2 Competitors also agree to take any and all responsibility for damages caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility the Event Organizers, the Yacht Club Costa Smeralda, Audi, the TP52 Class, the Super Series Eventos Desportivos LDA representatives, the sponsors and their agents, and all persons involved in the organisation under whatever qualification and to accept full responsibility for the behaviour and dress of the boat's crew, representatives and guests.

1.3 Competitors are to be acquainted with WS RRS Part 1 Fundamental Rule 4:

"The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".
