









#### NOTICE OF RACE

#### Organising Authority (OA) & Venue

The Giorgio Armani Superyacht Regatta is organised under the authority of the Italian Sailing Federation, from 26 to 30 May, by the Yacht Club Costa Smeralda with the support of the Superyacht Racing Association.

The event includes the 20th edition of the Southern Wind Rendezvous and Trophy (see paragraph 3.2).

The venue for the event is the Yacht Club Costa Smeralda, Porto Cervo (Sardinia).

In all the rules governing this event, the notation [NP] denotes a rule that shall not be ground for protests by a boat and the Protest Committee may refuse to hold a hearing. This changes RRS 60.1 and 63.2(a).

#### 1. The Rules

- 1.1 The regatta will be governed by:
- (a) The rules as defined in the Racing Rules of Sailing (RRS) 2025 2028 and Appendix SY (Annex B);
- (b) The ORC Superyacht Rule (ORCsy).
- (c) The World Sailing Offshore Special Regulations Category 4;
- (d) This Notice of Race including Annexes and the Sailing Instructions including the Exhibits and the Appendices. In the event of a discrepancy between the Notice of Race and the Sailing Instructions, the Sailing Instructions take precedence. This changes RRS 63.5(c).
- (e) The organising authority (OA) reserves the right to amend this Notice of Race in accordance with RRS 89.2(b). Any amendments will be posted on the Official Notice Board on the YCCS website <a href="www.yccs.com">www.yccs.com</a>. During the regatta, amendments to this Notice of Race will be posted on the online Official Notice Board and as a courtesy to the competitors also sent via WhatsApp to the contacts provided on the Entry Form. Each boat shall have at least one device connected to the internet with WhatsApp installed.
- f) RRS 48.1 does not apply to water used in a water ballast system that is declared and described in a yacht's measurement certificate. This changes RRS 48.1.
- g): Italian Sailing Federation Prescriptions, posted on the WS Website HERE, will apply.
- 1.2 Italians crews shall be FIV members and have a valid medical certificate and Italian boats shall have valid FIV authorization to display advertising (if applicable). Foreign competitors must comply with the rules of their national authority.
- 1.3 As part of the registration process, the OA requests from each participating boat a declaration of the boat's insurance company stating that the boat has a valid certificate of insurance including third party cover with a minimum value of Euro 1,500,000.00 per accident, including cover for racing and taking into account the value of the boats racing and the measure of damages likely to arise in the event of an accident (NoR 19).
- 1.4 English is the official language of the event. If there is a conflict between languages the English text will take precedence.
- 1.5 The Registration Nationality of a yacht is indicated by the owner of the boat as set out in the entry form ("Racing for" section).
- 1.6 The OA takes a proactive stance on safe racing, prudent seamanship and good sportsmanship. Safe racing is the responsibility of everyone involved in superyacht regattas. The superyacht safety protocol within this Notice of Race and the Sailing Instructions stresses the concept that the priority is on safety and prudent seamanship, not competitive advantage.
- 1.7 The yachts' racing tacticians and RRS Afterguard Members are expected to meet immediately following the racing to discuss and resolve any minor issues pertaining to competitive advantage, safety or sportsmanship.
- 1.8 [DP] Environmental responsibility: It is recalled the Basic Principle which states: "Participants are encouraged to minimize any adverse environmental impact of the sport of sailing", it is recommended that care be taken to always protect the environment during and after the event. Especially attention is drawn to RRS 47 -TRASH DISPOSAL- which states: "Competitors and support persons shall not intentionally put trash in the water. This rule always applies while afloat."

#### 2. Advertising

- 2.1 Advertising shall be displayed in accordance with Regulation 20 World Sailing Advertising Code and, for **Italian yachts only**, the "*Normativa 2026 per l'esposizione della pubblicità nelle manifestazioni veliche in Italia*". Non-Italian yachts shall comply with their national authority advertising rules.
- 2.2 [NP][DP] Yachts will be required to display the event advertising and sponsor's pennant on the backstay throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race and the event battle-flag on the forestay throughout the same period, but only while moored.
- 2.3 The OA will supply the pennants and flags at registration.
- 2.4 The OA may also require the installation, at no cost to competitors, of onboard video cameras for the official television production and/or a tracking system.
- 2.5 Yachts intending to display advertising during the regatta shall state in the entry form the nature of such advertising.
- 2.6 [NP][DP] Yachts are responsible for informing advertisers and sponsors that no activities advertising any brand will be permitted ashore within the Porto Cervo Marina Area without written consent of the OA obtained before the start of the Regatta.
- 2.7 The regatta logo, the Yacht Club Costa Smeralda burgee and all other associated logos shall not be used by any competitor without the prior written permission of YCCS.
- 2.8 [NP] [DP] All captains are directed to RRS Appendix G, IDENTIFICATION ON SAILS. Your attention is specifically directed to G1.2 (a) (3) "contrasting color to the body of the sail". Boats national letters and sail numbers must contrast with the sail color. If the letters and numbers do not contrast with the sail color, the boat may be scored DSQ without a hearing. This changes RRS A5.1.

#### 3. Eligibility

- 3.1 The regatta is open to sailing yachts with LOA of 80 feet or above with a current ORC Superyacht (ORCsy) handicap certificate.
- 3.2 The regatta will feature the Southern Wind Rendezvous and Trophy 2026. Southern Wind yachts can either race in the Giorgio Armani Superyacht Regatta or enjoy the Rendezvous formula (see Annex D).
- 3.3 Competitors must be at least 12 years old on the first race of the event; crew members between 12 and 18 years old shall deliver at registration a disclaimer signed by a parent or guardian (the Parent Guardian Declaration form will be available on the YCCS website).
- 3.4 The OA will adhere to all current regulations issued by World Sailing that are in effect on the date of the event regarding participants from Russia and Belarus.

#### 4. Classes, Divisions & Racing Format

- 4.1 The OA will, at its sole discretion, divide the fleet into classes based on size, performance characteristics, speed potential and composition of the fleet. A notice with the preliminary breaks will be posted on the YCCS website by 24 May.
- 4.2 Depending on fleet composition, it is the intent of the OA to have a Superyacht Class (or Classes) and a Southern Wind Rendezvous Class. Within each class there will be a *Corinthian Spirit Division* for yachts that comply with the criteria in Annex E; there will be no separate "Corinthian Spirit Division/Class" as such. See SYRA <u>Definition</u> for the eligibility criteria for Superyacht classes and Annex D for Southern Wind Rendezvous Class.
- 4.3 At the OA's discretion, all classes may sail different courses on any given day based on the speed potential and sailing characteristics of the yachts.
- 4.4 Racing Format: It is the intent of the race committee to feature the staggered start racing formats for all classes.
- 4.5 <u>NOT RACING ENTRIES</u>: yachts wishing to participate in the social program of the Giorgio Armani Superyacht Regatta, without racing can do so by specifying in the Entry Form. The same entry process and entry fee shall apply. Not racing entries will only need to indicate the number of people attending the social activities on the Entry Form.

#### 5. Entries

- 5.1 Entries shall be made by completing the attached Official Entry Form (Annex A) and shall be received by the YCCS Race Office by 15 April together with the non-refundable entry fee as follows:
- YCCS Members €6000 Non-Members of YCCS €6500. *A reduced entry fee with a 30% discount is available for boats whose entries are received by 15 March.*
- 5.2 For non-members of the Superyacht Racing Association (SYRA) there is a fee of €1100\* in addition to the entry fee. \*All SYRA sanctioned superyacht regattas in the 2026 season require non-SYRA members to contribute to the SYRA which is committed to improve the safety of superyacht racing and enhancing fair superyacht handicapping. - 5.3 The entry fee may be paid by credit card or by bank transfer as stated in detail on the entry form.
- 5.4 At the absolute discretion of the OA, late entries may be accepted after 15 April.

#### 6. Schedule

6.1 Tuesday 26 May: Registration, Inspection and Captains' Briefing. Captains' Briefing will be held at YCCS at 18.00.

- 6.3 Prize Giving, Saturday 30 May at 17.30 at the YCCS Piazza Azzurra.
- 6.4 The organizing authority and the race committee reserve the right to modify the programme based on weather conditions and other unforeseen circumstances.
- 6.5 Four coastal races are scheduled of which one must be completed to constitute a series.

#### 7. Handicap Certificates & Measurement

- 7.1 A valid ORCsy certificate is required from all competitors except for the yachts participating in the Southern Wind Rendezvous formula. Certificates will be issued to the yacht by the rule authority, the Offshore Racing Congress
- ( <u>www.orc.org</u>). To apply for a certificate and for additional information on the ORC Superyacht Rule (ORCsy) contact the ORC office at: <u>sy@orc.org</u>. The handicap application and fee must be received by the ORC no later than 16 April.
- 7.2 All measurements required shall be submitted as part of the application process for an ORCsy certificate. The ORC will accept declared data when measurement data is not available. The ORC, at its discretion, may implement hull data from design offices and sail data from sailmakers.
- 7.3 A list of the handicaps of the yachts will be posted on the online Official Notice Board on the YCCS website <a href="https://www.vccs.com">www.vccs.com</a> by 24 May.
- 7.4 The deadline for providing the yacht's configuration to the ORC is two weeks prior to the first scheduled race of the series. Yacht configuration includes sails declared for the regatta. Except in the case of rating office error or (at the discretion of the ORC Rule Authority) other errors which change the values, no changes to yacht configuration will be accepted. In exceptional circumstances, the deadline can be extended.
- 7.5 Yachts shall be available for inspection not later than 11.00 on 26 May. For yachts already in Porto Cervo, inspections may be carried out on 25 May. Yachts may be inspected and/or check measured at any reasonable time before or during the regatta and will be performed only by measurers approved by the OA.

#### 8. Registration

- 8.1 The official forms (entry form, crew list etc...) will be provided by the OA and published on the YCCS website www.yccs.com.
- 8.2 At final registration on 26 May the following documents shall be on file with the OA:
- (a) 2026 ORCsy certificate (provided to the OA directly by ORC);
- (b) Signed Entry Form;

#### (c) For Italian Competitors/Crews Only:

- FIV cards with medical certification (foreign competitors must comply with the rules of their national authority).
- FIV authorization to display advertising on yachts (only and if present);
- (d) RRS Afterguard Member Compliance Form (Annex C);
- (e) Parent Guardian Declaration form (if applicable see Paragraph 3.3).
- 8.3 Without the written approval of the race committee whose discretion shall be full and unfettered:
- (i) yachts not complying with the requirements of NoR 8.2 are not eligible for the event;
- (ii) the value of ORCsy certificates issued by 26 May shall not be modified (see NoR 7.4) Yachts shall not be entitled to redress in respect of a decision of the protest committee under this paragraph. Changes RRS 61.1(a).

#### 9. Sailing Instructions

- 9.1 The Sailing Instructions will be available on the YCCS website <u>www.yccs.com</u> by 25 May.
- 9.2 As part of its environmental initiatives, YCCS will not issue paper copies.

#### 10. Racing Area & Courses

- 10.1 The racing area will be in North-eastern Sardinian waters.
- 10.2 The courses to be sailed will be coastal courses along the coast and among the islands in the vicinity of Porto Cervo.

#### 11. Scoring

- 11.1 The Low Point System Appendix A shall apply except that there will be no discard.
- 11.2 The Superyacht Class will be scored using corrected times calculated by the Polar Curve Scoring and Constructed Course Scoring method for <u>ORCsy rule 504</u>.

#### 12. Moorings and Diving

- 12.1 The entry fee includes mooring fees from 10.00 on 26 May to 10.00 on 31 May at Porto Cervo Marina or Port East, provided that the entry is completed by the closing date for entries.
- 12.2 Moorings may not be available for late entries.
- 12.3 The cost of electricity, water, tenders or additional periods of time are not included in the entry fee and must be paid directly to the Marina Office. The mooring place for any additional period (before and/or after the event), if available, may be at Porto Cervo Marina or East Dock (Porto Vecchio) and different from the mooring place assigned during the event. Assignment of moorings will be based on availability of moorings and the characteristics of the boats.
- 12.4 To reserve moorings prior and after the dates indicated in NoR 12.1 and for tenders, please send your mooring requirement to <a href="mailto:e.pileri@marinadiportocervo.com">e.pileri@marinadiportocervo.com</a> c/c <a href="mailto:info@marinadiportocervo.com">info@marinadiportocervo.com</a> / <a href="mailto:secretariat@yccs.it">secretariat@yccs.it</a>. For further information about the marina services and the price list please visit the Marina Porto Cervo web site: <a href="mailto:www.marinadiportocervo.it">www.marinadiportocervo.it</a>.
- 12.5 Local regulations require that all yachts must inform the Harbourmaster's Office by radio on VHF Channel 9 when they first arrive in Porto Cervo and each time they leave or enter the Harbour. When moored, it is mandatory for all participants to visit the Harbourmaster's Office to finalize their registration. Participants should consult the Harbour Safety Regulation at the following link: <a href="https://www.marinadiportocervo.com/regolamento/">www.marinadiportocervo.com/regolamento/</a>.
- 12.6 [DP] Independent swimming/diving inside the harbour is forbidden. Only the Harbourmaster's divers are authorised to swim/dive inside the harbour and they can be booked on VHF Channel 9 or by email to: <a href="mailto:e.pileri@marinadiportocervo.com">e.pileri@marinadiportocervo.com</a> and when at their regatta berths and after permission by the Marina Office, may get their bottom cleaned by the Harbourmaster's divers.
- 12.7 All competitors are required by the Harbour Safety Regulations to keep the marina docks in order and provide appropriate space for others moored on the same dock. Sails and dock boxes shall be kept in the immediate vicinity of the assigned mooring place. The Harbourmaster and the Coast Guard will monitor the docks to ensure compliance.
- 12.8 It is reminded that infractions to the above-mentioned safety rules or inappropriate behaviours reported by the Harbourmaster or the Coast Guard to the OA may lead to discretional penalties by the Jury or the exclusion from the regatta. Possible breaches of these regulations and requirements are not grounds for protests by boats. This changes RRS 60.1. 12.9 [DP] Sailing inside the harbour is forbidden.

#### 13. Communications and Electronic Aids

- 13.1 [DP] Yachts shall be equipped with a Marine VHF transceiver operating on VHF 8, 9, 16 and 72.
- 13.2 Other types of electronic aids, including radar, VOR, satellite, AIS, etc., are permitted. No external aids, outside assistance or information shall be used during the races, except weather forecast information.
- 13.3 Yacht to yacht communication is allowed and encouraged to allow safe racing and navigation during the regatta. A dedicated VHF channel (channel 8) will be used for this purpose.
- 13.4 [DP] Yachts equipped with Automatic Identification System (AIS) are required to operate their AIS system from the time they approach the starting area until departing the finishing area following the race. AIS equipment shall not be removed from the yacht prior to the regatta.
- 13.5 The online Official Notice Board (ONB) is located at <a href="www.yccs.com">www.yccs.com</a>. Communication with competitors will be via the Online ONB and/or e-mails and/or WhatsApp. Additionally, the race committee will make courtesy broadcasts to competitors on VHF. Each boat shall have at least one device connected to the internet with WhatsApp installed.

#### 14. Competitors drones

- 14.1[NP] [DP] Teams or their representatives shall not fly drones over the Giorgio Armani Superyacht Regatta shore base or over the race area during training or racing days without complying with local laws and in any case unless prior written approval by the OA has been obtained.
- 14.2 The approval, granted at sole discretion of the OA, may impose similar limitations as applicable to support boats (further details will be provided in the Sailing Instructions).
- 14.3 The risk and responsibility for flying any drone is with the person flying the drone at all times and images made inside the race area shall be shared with the OA, race committee, protest committee or competitors at their reasonable request.

#### 15. Designated RRS Afterguard Member Compliance

- 15.1 Each yacht shall designate one member of the afterguard who is currently active with and has a thorough understanding of The Racing Rules of Sailing (RRS) and submit the completed Compliance Form (Annex C) **no later than 26 April** with information on the designated RRS Afterguard Member.
- 15.2 If the RRS Afterguard Member submitted a form at a previous regatta and the name is listed on the SYRA website <a href="https://superyra.org/after-guard/">https://superyra.org/after-guard/</a>, then the yacht is not required to resubmit the form.
- 15.3 The OA will review all compliance forms **prior to 10 May** and communicate any concerns or issues to the boat Captain.
- 15.4 The RRS Afterguard Member may be the yacht's helmsman, navigator, racing tactician or communications crew member (who monitors the VHF safety channel) if they meet the stated criteria. This individual's role is to interact closely with the other members of the afterguard. Boat captains should not be the designated RRS Afterguard Member due to the specific RRS related criteria that this position requires and the fact that the overall safety of the yacht is their responsibility.

- 15.5 The boat captain shall designate a Communications Officer who shall monitor and communicate on the VHF safety channel (channel 08). It is recommended that this individual have experience with radio protocol and experience with and an understanding of the RRS and Appendix SY.
- 15.6 The boat captain shall determine what crew position the RRS Afterguard Member assumes (tactician, helmsman, navigator, strategist, etc.). The designated RRS Afterguard Member may assume the position of Communications Officer.
- 15.7 The RRS Afterguard Member shall attend all pre-race briefings and shall be responsible for ensuring the Daily Declaration Form is returned to the race office by email (editable form will be available on the YCCS website) as soon as practicable following racing each day, but no later than two hours after finishing.

#### 16. Protest Committee

Protests will be heard by an International Protest Committee.

#### 17. Trophies and Prizes

- 17.1 Giorgio Armani series trophies for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place in each Class will be awarded. Trophies for the 1<sup>st</sup> place in the Corinthian Spirit Division in each Class will be awarded.
- 17.2 The Silver Jubilee Cup is awarded to the Class winners.
- 17.3 Trophies for the Southern Wind Rendezvous and Trophy.
- 17.4 The YCCS Trophy will be presented to the highest placed YCCS Member.
- 17.5 Additional trophies may be awarded at the discretion of the OA.

#### 18. Disclaimer, Media Rights.

- 18.1 Competitors agree to be bound by the World Sailing RRS 2025/2028, this NoR and the SI. Competitors agree that the sole and inescapable responsibility for the nautical qualities of any boat participating in the Giorgio Armani Superyacht Regatta 2026, including her rigging, safety equipment on board and the competence, behavior and dress of her crew, is that of the Owner/Charterer of the boat. Competitors also agree to take any and all responsibility for all damages whatsoever caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, and hereby relieve from any responsibility, and agree to indemnify on a full indemnity basis and hold harmless, the OA and sponsors and their representatives in respect of any claim arising there from.
- 18.2 Competitors shall apply RRS Part 1 Fundamental Rule 3: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".
- 18.3 In summary, competitors agree that the OA and sponsors and their representatives have no responsibility for loss of life or injury to members or others, or for the loss of, or damage to any vessel or property.
- 18.4 As part of the registration process, the boat representative will be required to sign a declaration accepting this disclaimer of liability.

#### 19. Insurance & Indemnity

- 19.1 The OA requests from each participating boat a declaration of the boat's insurance company stating that the boat has a valid certificate of insurance including third party cover with a minimum value of Euro 1,500,000.00 per accident, including cover for racing and taking into account the value of the boats racing and the measure of damages likely to arise in the event of an accident.
- 19.2 The responsibility to hold adequate insurance cover for Third Liability and Third-Party Insurance (Property and Persons) is to the owners or the skippers alone.
- 19.3 The OA is not responsible for verifying the status or validity of insurance certificates.
- 19.4: Support boats shall register on the dedicated section of the entry form and collect the support boat identification flag at the race office during registration on Tuesday 26 May. The support boat identification flag shall be displayed throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race of the regatta. The OA requests from each support boat a declaration of the boat's insurance company stating that the boat has a valid certificate of insurance including third party cover with a minimum value of Euro 1,500,000.00.

#### 20. Risk Statement

- 20.1 By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent injury or death by drowning, trauma, hypothermia, or other causes.
- 20.2 Competitors participate in the event entirely at their own risk. The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during or after the event. General conditions as stated in detail on the entry form.
- 20.3 Not Italian competitors must comply with the requirements of their MNA and be in possession of accident coverage, including death and permanent disability as per current regulations.

22.4 Authorisation shall be requested from the OA and a form assuming liability in the case of damage to third parties shall be completed. In such event the OA will also specify the rules governing the use of drones on the regatta course.

# Notice of Race - Annex B - page 1/2 APPENDIX SY SUPERYACHT RACING RULES

When stated in the notice of race, races shall be sailed under The Racing Rules of Sailing for 2025-2028 as changed by this appendix.

Version 5.0, July 2024.

#### SY1 TERMINOLOGY

'Superyacht' means a boat with a hull length greater than 30.5 metres.

#### SY2 Changes to the Definitions and the Rules of Part 1 and Part 2

#### SY2.1 The definition *Keep Clear* is changed to:

**Keep Clear** A boat *keeps clear* of a right-of-way boat if the right-of-way boat can sail her course with no need to take avoiding action and with no less than 40 metres between the boats.

#### SY2.2 The definition *Mark* is changed to:

*Mark* An object or *waypoint* the sailing instructions require a boat to leave on a specified side, a race committee vessel surrounded by navigable water from which the starting or finishing line extends, and an object intentionally attached to the object or vessel. However, an anchor line is not part of the *mark*.

#### SY2.3 The definition *Mark-Room* is changed to:

#### Mark-Room Room for a boat

- (a) to sail to the *mark* when her *proper course* is to sail close to it,
- (b) to round or pass the *mark* on the required side, and
- (c) to leave it astern,

with no less than 40 metres between the boats.

#### SY2.4 Add new definition *Overtaking*:

**Overtaking** A boat is *overtaking* when she is approaching a boat from *clear astern*. She remains the *overtaking* boat until she is *clear ahead*. The other boat is the boat being *overtaken*.

#### SY2.5 The definition *Room* is changed to:

**Room** The space a boat needs in the existing conditions, including space to comply with her obligations under the rules of Part 2 and rule 31, while manoeuvring promptly in a seamanlike way, with no less than 40 metres between the boats.

#### SY2.6 Add new definition *Waypoint*:

**Waypoint** A geographic position on the surface of the water defined by WGS 84 latitude and longitude coordinates expressed in degrees decimal minutes (DDM).

#### SY2.7 The definition *Zone* is changed to:

**Zone** The area around a *mark* within a distance of 300 metres of it. A boat is in the *zone* when any part of her hull is in the *zone*.

#### SY2.8 Add new rule 1.3:

#### 1.3 Communication

At all times while in the racing area, a boat shall

- (a) monitor the safety channel specified in the sailing instructions,
- (b) respond promptly to a hail from another boat, and
- (c) communicate with other boats on matters of safety.

#### SY2.9 Rule 17 is changed to:

#### 17 ON THE SAME TACK; PROPER COURSE

- 17.1 A *leeward* boat shall not sail above her *proper course* while she is within 80 metres of the *windward* boat.
- 17.2 When boats on the same *tack* are within 80 metres of each other, a boat being *overtaken* shall sail her *proper course* until the *overtaking* boat becomes *overlapped* with her. However, if a boat being *overtaken* would break another rule of Part 2 in order to sail her *proper course*, rule 17.2 does not apply.
- 17.3 If there is reasonable doubt that a boat is *overtaking* another boat, it shall be presumed that she is.

#### SY3 Changes to the Rules of Part 4 and Part 5

#### SY3.1 Rule 42.3(g) is changed to:

(g) Any means of propulsion may be used to help a person or another vessel in danger, or as required to comply with rule 14, Avoiding Contact.

#### SY3.2 Rule 60.4(c)(1) is changed to:

- (c) However, rule 60.4(b) does not apply to a *protest* from
  - (1) the protest committee or race committee if it learns of an incident involving a boat that may have resulted in injury or serious damage, that may have sailed within 40 metres of another boat, or that did not respond to a radio hail.

### Notice of Race Annex D Eligibility Criteria - Southern Wind Rendezvous and Trophy

#### **Background**

The Giorgio Armani Superyacht Regatta offers a beautiful venue at the Yacht Club Costa Smeralda, spectacular sailing in and around the Archipelago and unique shore side social events. In recent years, the Southern Wind management team, in conjunction with the Yacht Club Costa Smeralda, has offered a popular sailing event exclusively for Southern Wind yacht owners that has been incorporated into the Giorgio Armani Superyacht Regatta.

The rendezvous offers informal racing and fleet sailing each day to a pre-determined rendezvous location where participating yachts anchor for lunch before sailing or racing back to the club later each afternoon. This on-water format has been embraced by participating Southern Wind yacht owners and the regatta organizer.

#### **Rendezvous Sailing**

- There will be four informal coastal races offered from 27 to 30 of May;
- The Southern Wind Rendezvous start will be scheduled after the racing classes;
- The Southern Wind Rendezvous will feature a staggered start;
- There will be no requirement for handicap certificates for yachts participating in the Southern Wind Rendezvous;
- Safe sailing has been and will continue to be a top priority of the regatta organizer;
- It is reminded that NoR paragraph 15 ( **Designated RRS Afterguard Member Compliance** ) applies for the Rendezvous participants.

#### Eligibility Criteria for the Southern Wind Rendezvous Division

- Participation is open to all Southern Wind yachts;
- A completed Entry Form, Crew List and Entry Fee must be submitted prior to the deadlines established in the Notice of Race;
- Yachts electing to participate in the Rendezvous will adhere to the Racing Rules of Sailing, Appendix SY (Annex B)
  and the rules and regulations established in the regatta racing documents (Notice of Race, Sailing Instructions and
  any amendments).
- For Italian /Crews FIV cards without medical certification (foreign competitors must comply with the rules of their national authority). FIV cards can be issued directly in Porto Cervo by the OA at the cost of 10 € (Italian Fiscal code and ID are required).

#### Notice of Race Annex E Eligibility Criteria – Corinthian Spirit Division

Within each Class there may be a Corinthian Spirit Division for yachts that comply with the following criteria:

- 1. Only one headsail which shall be attached to the forestay and can be furled is allowed.
- 2. Boats with an overlapping furling genoa >115% LP may also have a second non-overlapping furling jib hoisted on a fixed inner stay.
- 3. Only one furling headsail set flying (HSF) tacked in front of the forestay is allowed, provided it is declared in the ORCsy certificate. The HSF marked as "inner" in the certificate (such as Genoa Staysail, Spinnaker Staysail, etc.) is also allowed.
- 4. Only one spinnaker is allowed, provided it is declared in the ORCsy certificate. In the absence of an HSF tacked in front of the forestay, a second spinnaker that has a furling system and with a mid girth-foot ratio between 75% and 85% is also allowed.
- 5. Yachts shall sail in fully cruising mode: no cruising material shall be disembarked to make the yacht lighter, other than the tender, spray-hoods, biminis, anchor and chain (the last shall be declared in the certificate). An event measurer will inspect yachts entering the Corinthian Division to check they comply with these rules.
