The Maxi Yacht Rolex Cup is organized under the authority of the Italian Sailing Federation, from 6 to 12 September 2026 by the Yacht Club Costa Smeralda (YCCS) in conjunction with the International Maxi Association (IMA) and sponsored by Rolex. The Maxi Yacht Rolex Cup is part of the IMA Mediterranean Maxi Inshore Challenge 2026.

[NP] denotes a rule that shall not be grounds for protests by a boat. If a boat protests under a rule marked [NP], the International Jury may refuse to hold a hearing. This changes RRS 60.1 and 63.2(a).

1. RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The World Sailing Offshore Special Regulations (OSR) Category 4 will apply.
- 1.2.1 OSR Category 4 compliance will be evaluated by the Technical Committee, which may address related issues with a NoR Amendment.
- 1.3 The IMA Class Rules.
 - 1.3.1 Owner Driver:
 - (a) IMA Rule C.2.1.(a).2 (OWNER DRIVER) applies to Maxi;
 - (b) IMA Rules C2.2 to C2.5 (OWNER DRIVER) apply to helmsmen in Maxi.
 - 1.3.2 For Owner Drivers from the age of 75, the conditions of IMA Rule C.2.2 are relaxed as follows:
 - (a) WL races: Owner Driver or Charterer Helm only from the preparatory signal. Per hour, a 10-minute break is permitted. The Owner Driver or Charterer Helm shall drive the first and final mile of the race. The break(s) shall take place between mark roundings and avoid clearly imminent manoeuvres (tack/gybe).
 - (b) Coastal Races (any non-WL race up to 60 miles): Owner Driver or Charterer Helm only from the preparatory signal. The first hour, a 10-minute break is permitted, thereafter a Relief Helm may helm up to a total of 30 minutes per hour and after four hours up to a total of 45 minutes per hour. The Owner Driver or Charterer Helm shall drive the first mile and final two miles of the race.
 - 1.3.3 [NP] The IMA Class Rule C.2.6 Guests applies. Guests may be varied per race day but shall preferably be applied for before the close of registration using the IMA Guest Application Form. Alternatively, it may be applied on a daily basis using the IMA Daily Guest Application Form, which shall also be used to apply for guest changes. The OA may set additional rules, refuse guests, or cancel the approval in case of abuse of the arrangement.
 - 1.3.4 [NP] The IMA Class Rule C.2.7 Bonus Crew applies. A maximum of two Bonus Crew may be added to the maximum crew number as IRC or Reduced Crew certified. Bonus Crew is defined as:
 - a) A female crew member of any age.
 - b) A crew member who is 21 years old or younger at the time of the prize giving. And
 - c) Bonus Crew shall be included in the crew for every race of the event. Any changes shall be submitted and approved as per NoR 1.4.
 - d) When racing on IRC Reduced Crew rating (NoR 4.1.2), the total number of Crew **excluding Bonus Crew and Guests (NoR 1.3.3)** shall not exceed **70% of the crew number shown on the IRC certificate (0.5 and above rounded up)**
 - e) When not racing on IRC Reduced Crew rating (NoR 4.1.2), the total number of Crew **excluding Bonus Crew and Guests (NoR 1.3.3)** shall not exceed the crew number shown on the IRC certificate.

- 1.4 Boats shall race with the entire crew declared on the crew list form for the regatta. Any crew change shall have proper reason and the request shall be submitted for approval to the race office by email (secretariat@yccs.it c/c technicaloffice@internationalmaxiassociation.com) no later than 09.30 on the day the change takes place. In case of emergency, crew changes made after 09.30 shall be communicated to the IMA ATO (technicaloffice@internationalmaxiassociation.com) as soon as reasonably possible and once ashore in writing to the race office within the protest time limit. **PLEASE NOTE:** Proper reason may be incapacity to race, like due to illness, or having to leave Porto Cervo, like for family reasons. There is every intention to be lenient when judging proper reason.
- 1.5 The Rating Rules:
- 1.5.1 The 2026 ORCs_y Rule for Supermaxi will apply; below deck spinnaker retriever systems are allowed subject to a 0.5% rating penalty as per ORCs_y Rule 304.4.
- 1.5.2 The 2026 IRC Rule, Parts A, B and C, for Maxi will apply.
- (a) For the purposes of IRC rules 21.1.5 (d) and (e), this regatta is on consecutive days, yet the sails carried on board need not remain the same for the duration of the event, but sails need to remain the same for each day. For the purpose of this rule, the day begins when the boat leaves the harbour for the first time each day and ends when the boat returns to the harbour after racing. Competitors may transfer their sails from or to the dock or from their boat using their support vessel. However, the transfer shall be within the harbour and only that day's race sails shall be on board the support vessel during the transfer. The Equipment Inspectors may carry out checks at any stage of the process.
- (b) IRC Rule 22.4.2, if applicable, is deleted and replaced with: "The maximum number of crew on board shall be the Crew Number printed on her certificate. There is no weight limit" (note that NoR 1.3.4 Bonus Crew applies and that in consideration of IRC REDUCED CREW (see NoR 4.1.2b and 4.1.2c), the crew number printed on the IMA certificate shall apply).
- 1.5.3 The 2026 ORC_{mh} Rule for Maxi Catamaran will apply.
- 1.5.4 RRS 48.1 does not apply to water used in a water ballast system that is declared and described in a yacht's measurement certificate (changes RRS 48.1).
- 1.5.5 If allowed by class rules, steering, ram and winch systems powered by force other than manual, as well as moveable appendages, trim tabs, water ballast and canting keels are permitted if each feature is declared on the IRC, ORCs_y and ORC_{mh} certificate (changes RRS 51 and 52).
- 1.6 Italian Sailing Federation Prescriptions, posted on the WS Website [HERE](#), will apply. Italian crews shall be FIV members and have a valid medical certificate, and Italian boats shall have valid FIV authorization to display advertising (if applicable). Foreign competitors must comply with the rules of their national authority.
- 1.7 The official language is English. If there is a conflict between languages, the English text will take precedence.
- 1.8 The registered nationality of a boat is indicated by the owner of the boat as set out in the entry form. If not indicated, the sail national letters or the owner's nationality will be used.

2. SAILING INSTRUCTIONS

- 2.1 The Sailing Instructions will be published online on 6 September on the Official Notice Board ([ONB](#)).

3. COMMUNICATION

- 3.1 The Official Notice Board will be online here: [ONB](#)
- 3.2 [NP] All boats shall be equipped with a Marine VHF transceiver operating on VHF channels 09, 16, 71 and 72.
- 3.3 Communication with competitors will be via the ONB. Courtesy notices may also be sent via WhatsApp or e-mail when practicable. Each boat shall have at least one device connected to the internet with WhatsApp installed. Additionally, the race committee may make courtesy broadcasts to competitors on VHF. Failure to send or receive courtesy notices or broadcasts will not be grounds for redress (changes RRS 61.4(b)(1)).
- 3.4 RRS 41 is changed such that, for safety purposes, boat-to-boat communication is allowed and encouraged. A dedicated VHF channel shall be used for this purpose and will be announced at the Skippers' Briefing and published in the [Sailing Instructions](#).

4. ELIGIBILITY AND CLASSES

- 4.1 The regatta is open to the following boats with a LH not less than 18.29 meters as defined by the IMA Class Rules, with a valid rating certificate, endorsed if specified below in NoR 4.1.2 (please note NoR 4.1.2 (a) for non-endorsed options and NoR 4.4 and 5.2):
- 4.1.1 [NP] Supermaxi yachts with a valid ORCs_y Measured Certificate. Please note that if the minimum of 4 Supermaxi entries (NoR 4.2) are not met, the IMA ATO will assist in arranging IRC certification in order to facilitate Supermaxi yacht participation in a [mixed class](#) with other Maxi yachts. Also, the OA may decide to combine a Supermaxi class start with the start of other Maxi yachts class close to the Supermaxi LH limit in the interest of fair and good competition for both.
- 4.1.2 [NP] Maxi yachts with a valid Endorsed IRC certificate. The Maxi class may be divided into sub-classes based on the IRC (Reduced Crew if applicable) TCC. Sub-class options are Maxi 1, Maxi Grand Prix, Maxi 3, Maxi 4 and Maxi 5. Maxi 1 will have a TCC upper limit of 2.200. [Maxi 4 will have a TCC lower limit of 1.250. Only in the event that a](#)

minimum of 4 Maxi 5 boats are entered in an event shall Maxi 5 be eligible to compete and they may be raced with Maxi 4. The other sub-class TCC bands will be determined after the close of entry and communicated as follows:

- Preliminary version, no later than September 3rd 2026.

- Final version, no later than September 5th 2026.

For guidance of the potential 2026 sub-class TCC bands, these were the 2025 bands:

Maxi 1: IRC TCC greater than or equal to 1.700. Maxi Grand Prix: IRC TCC greater than or equal to 1.600 and less than 1.700. Maxi 3: IRC TCC greater than or equal to 1.350 and less than 1.600. Maxi 4 IRC TCC Greater than or equal to 1.250 and less than 1.350. Maxi 5: IRC TCC less than 1.250.

Please note that:

- a) Maxi sub-classes 3, 4 and 5 may request the IMA Technical Office (ATO) IMA certification on the basis of a valid standard (non-endorsed) IRC Certificate.
- b) Maxi sub-classes 1, Grand Prix, 3, 4 and 5 are eligible to enter the event based on their IRC Reduced Crew rating, racing all races with a maximum crew number of 70% of the standard IRC crew number. In which case, the IRC Reduced Crew TCC will be used to determine sub-class allocation.
- c) If a boat considers the IRC REDUCED CREW choice, this shall be indicated on the Entry Form.
- d) If a boat elects to adopt the IRC REDUCED CREW rating, the IMA ATO shall be informed no later than 18.00 on 25 August technicaloffice@internationalmaxiassociation.com unless a different deadline is authorized by the OA.
- e) The IRC REDUCED CREW choice cannot be changed after 18.00 on 1 September 2026.

For further information, please contact the IMA ATO (technicaloffice@internationalmaxiassociation.com). Decisions of the OA under NoR 4.1.2 will not be grounds for redress. This changes RRS 61.4(b)(1).

4.1.3 Maxi Catamaran boats (with a LH not less than 18.29 metres) with a valid ORCmh certificate. Due to limited berthing space, a maximum of 5 boats will be guaranteed entry for this class. Selection will be primarily 'first come first served'. But at its sole discretion, the OA, in the interest of the best possible competition, reserves the right to override this principle as well as to extend the number of entries. Decisions of the OA under NoR 4.1.3 will not be grounds for redress. This changes RRS 61.4(b)(1).

4.2 Minimum number of boats for class and sub-class scoring:

4.2.1 A minimum of 4 boats is required for separate class and sub-class scoring in Supermaxi Class, and of 5 boats in Maxi unless the minimum is waived by the OA, with the approval of the IMA.

4.2.2 **World Championship status may be applied for the Maxi 1 and Maxi Grand Prix sub-classes.**

4.3 A valid (endorsed if applicable, see NoR 4.1) rating certificate and, if applicable, a valid class certificate issued by the appropriate Rating or Class Authority, shall be submitted with the entry form. Rating certificates shall then be approved by the IMA Technical Office (ATO), which issues IMA certification. The IMA ATO may require full or partial re-measurement or additional information. For early approval or information, please submit to: technicaloffice@internationalmaxiassociation.com.

4.4 All competitors shall comply with the World Sailing Eligibility Code. Competitors must be at least 12 years old on the first race day of the event; crew members between 12 and 18 years old shall deliver at registration a disclaimer signed by a parent or guardian (these forms will be available at the race office).

4.5 The OA will adhere to all current regulations issued by World Sailing that are in effect on the date of the event regarding participants from Russia and Belarus.

5. ENTRY AND ENTRY FEES

5.1 Entries shall be submitted on the official Entry Form (Annex1). The Entry Form, completed in full, and the rating and class certificates (NoR 4.4) shall be received by the YCCS Race Office not later than 30 July, accompanied by a non-refundable entry fee of € 5000. The entry fee for YCCS Members and/or IMA Members is € 4000.

5.2 If a boat elects to reconfigure, changing any measurement value requiring recertification, the new certificate shall be received by the OA not later than 18.00 on 1 September and be approved/IMA certified by the IMA ATO not later than 18.00 on 4 September, unless a different deadline is authorized by the OA. Any change to rating certificates after 18.00 on 1 September may only be as a result of inspections and controls.

5.3 Boats that do not comply with the registration requirements by the deadline specified in this NoR may be subject to a 1% penalty added to elapsed time for all races without a hearing. This changes RRS 60.5(b) and A5.1.

5.4 The OA retains the right to refuse any entry, following the provision of RRS 76. Entry confirmations will be communicated by the OA. For late entries, moorings are not guaranteed, and mooring fees are not included in the entry fee.

5.5 The entry fee can be paid by credit card or by bank transfer, and payment details are provided on the entry form. If the payment is made by bank transfer, a copy of the transfer confirmation is to accompany the entry form.

6. REGISTRATIONS

Final registration formalities shall be completed at the YCCS Race Office by 16.00 on 6 September unless the OA approves a later time, which it will do only under exceptional circumstances. At registration, in addition to the certificates mentioned in NoR 4.1.1, 4.1.2, 4.1.3, the following documents will be required:

- (a) Acceptance of the NoR, Disclaimer of Liability, Photography and TV rights consent and third-party liability

insurance as set out in the Entry Form.

- (b) Crew Declaration Form. All competitors shall be in compliance with the World Sailing eligibility rules. All boats, except those in the Supermaxi class, shall be in compliance with the IMA Owner/Driver rules (Helmsman designation form to comply with IMA Class Rule C.2);
- (c) For Italian competitors and boats only:
 - FIV cards and a valid medical certification;
 - Valid FIV authorization to display advertising on boat (if applicable);
- (d) Foreign competitors must comply with the rules of their national authority;
- (e) Parent Guardian Declaration form (if applicable – see NoR 4.5);
- (f) As part of the registration process, the OA requests from each entry a declaration of the boat's insurance company stating that the boat has a valid certificate of insurance, including third-party cover with a minimum value of Euro 1,500,000.00 per accident, including cover for racing and taking into account the value of the boats racing and the measure of damages likely to arise in the event of an accident (NoR 19).

Note: Support vessels shall register on the dedicated section of the entry form and collect the support vessel identification flag at the race office during registration on Sunday, 6 September. The support vessel identification flag shall be displayed throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race of the regatta. The OA requests from each support vessel a declaration of the insurance company stating that the vessel has a valid certificate of insurance including third party cover with a minimum value of Euro 1,500,000.00.

7. ADVERTISING, IDENTIFICATION NUMBERS, SAIL LETTERS AND NUMBERS

- 7.1 The World Sailing Advertising Code shall apply. For Italian boats only the “Normativa 2026 per l'esposizione della pubblicità nelle manifestazioni veliche in Italia” shall apply.
- 7.2 Boats will be required to display the following throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race of the regatta:
 - 7.2.1 Sponsor pennant on the backstay or centre back stanchion and a boom sticker (supplied at registration);
 - 7.2.2 Event battle flag, a sponsor pennant on the forestay throughout the same period while moored (supplied at registration);
 - 7.2.3 For selected classes and only if needed by the number of boats in a class, an identification number (rail panels) to be displayed clearly on both sides of the hull (supplied at registration);
 - 7.2.4 The OA may require the installation, at no cost to competitors, of on-board video cameras for the official television production and/or a GPS tracking system.
- 7.3 Boats intending to display advertising during the regatta shall state in the entry form the nature of such advertising. All advertising shall be approved by the OA.
- 7.4 Boats are responsible for informing advertisers and sponsors that no activities advertising any brand will be permitted ashore within the Marina area without written consent from the OA prior to the start of the regatta.
- 7.5 The regatta logo, the Yacht Club Costa Smeralda burgee and all other associated logos shall not be used by any competitor without the prior written permission of YCCS.

8. SCHEDULE

- 8.1 Saturday 5 September,
 Measurements & Inspections, in accordance with the Technical Committee schedule
Sunday 6 September
 Registration, Measurement, Inspection and Skippers' Briefing (18.00 at YCCS upper Terrace).
- 8.2 Race days:
 - Monday 7 September Race(s)
 - Tuesday 8 September Race(s)
 - Wednesday 9 September Race(s)
 - Thursday 10 September Reserve day (lay day)
 - Friday 11 September Race(s)
 - Saturday 12 September Race(s)
- 8.3 The scheduled time of the first warning signal each day will be at 12.00.
- 8.4 The IMA Annual General Meeting will be held at the YCCS on the scheduled reserve day at 10.30 or late that afternoon if there is racing that day.
- 8.5 On Saturday, 12 September, no warning signal will be made after 15.00.
- 8.6 Prize giving: Saturday 12 September at 17.30.
- 8.7 Scheduled number of races and format:
 - 8.7.1 Supermaxi if not combined with another start, Maxi 3, Maxi 4, Maxi 5 and Maxi MH: maximum of 5 coastal races.
 - 8.7.2 Maxi 1: maximum of 6 races, with a combination of 4 coastal races (1 per day) and 1 day with 2 windward/leeward races. **In case of World Championship status (NoR 4.2.2) this may be changed to a maximum of 7 races, with a combination of 3 coastal races (1 per day) and 2 days with each 2 windward/leeward races.**
 - 8.7.3 Maxi Grand Prix: maximum of 7 races, with a combination of 3 coastal races (1 per day) and 2 days with each 2

windward/leeward races.

- 8.8 The OA and/or race committee reserve the right to modify the schedule based on weather conditions or other unforeseen reasons.

9. EQUIPMENT INSPECTION

- 9.1 All boats shall be at their berth in Marina Porto Cervo not later than 09.00 on 6 September. Earlier arrivals on 5 September shall remain at their berth and be available to the Technical Committee until the boat's inspection and controls are completed or at such time as agreed with the IMA ATO. To book an inspection slot, please contact: technicaloffice@internationalmaxiassociation.com
- 9.2 At any reasonable time throughout the regatta period, race committee or technical committee members may undertake random inspections and measurement checks on any boat. This may include measurement, equipment checks and weighing, or determination of displacement by other means as approved by the IMA ATO. In the event of an hearing request, access for inspections may be requested at any time.
- 9.3 A list of the boat ratings will be posted on the event ONB by 16.00 on 5 September. The list will remain posted on online ONB during the event. The Protest Time Limit for rating protests by boats, except relating to changes made during the regatta, it is at 18.00 on 6 September.

10. PENALTY SYSTEM, INTERNATIONAL JURY

- 10.1 For Supermaxi if not combined with another start, Maxi 3, 4, 5 and Maxi MH the Scoring Penalty, as provided in RRS 44.3, applies, and replaces the One-Turn and the Two-Turns Penalty.
- 10.2 For Maxi 1 and Maxi Grand Prix, RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.
- 10.3 Penalties for breaches of a rule other than a rule of Parts 1 or 2 and rule 31 of the RRS may be less than disqualification if the jury decides.
- 10.4 Actions by official boats, drones or helicopters shall not be grounds for requesting redress by a boat. These changes RRS 61.1(a).
- 10.5 An International Jury will be appointed in compliance with RRS 91(b). Its decisions will be final as provided in RRS 70.3(a).

11. SCORING

- 11.1 The Low Point System RRS Appendix A shall apply without discards.
- 11.2 Results will be calculated based on "ToT" for IRC classes and by corrected time calculated by the Polar Curve Scoring and Constructed Course Scoring method for ORCs and ORCmh classes.
- 11.3 All races (W/L or Coastal) will have a coefficient of 1.0.
- 11.4 Two (2) races are required to be completed to constitute the series.

12. [NP] BERTHING

- 12.1 Depending on the characteristics of the boats, the entry fee includes berthing fees from 09.00 on 5 September to 10.00 on 13 September at Porto Cervo Marina or Port East provided that the completed entry form and entry fee are received by the YCCS race office before 30 July.
- 12.2 For late entries, berthing and berthing fees are not guaranteed and may not be included in the entry fee.
- 12.3 The cost for electricity, water, garbage, tenders, or additional time is not included in the entry fee and must be paid directly to the Marina Office. The berth for any additional period (before and/or after the event) may be at Porto Cervo Marina or East Dock (Porto Vecchio) and different from the berth assigned during the event. Assignment of berths will be based on the availability of berths and the characteristics of boats and depending on those, boats can be placed for the event also at Porto Cervo East Dock (Porto Vecchio).
- 12.4 To reserve berths prior to and after the times and dates indicated in NoR 12.1 and for tenders/support boats, submit your berthing requirement to: e.pileri@marinadiportocervo.com c/c info@marinadiportocervo.com / secretariat@yccs.it. For additional information about the marina services and the price list, please visit www.marinadiportocervo.it
- 12.5 Local regulations require that all yachts must inform the Harbourmaster's Office by radio on VHF Channel 9 when they first arrive in Porto Cervo and each time they leave or enter the Harbour. When berthed, it is mandatory for all participants to visit the Harbourmaster's Office to finalize their registration. Participants should consult the Harbour Safety Regulation at the following link: www.marinadiportocervo.com/regolamento/. All competitors are required by the Harbour Safety Regulations to keep the marina docks in order and provide appropriate space for others moored on the same dock. Sails and dock boxes shall be kept in the immediate vicinity of the assigned mooring place. The Harbormaster and the Coast Guard will monitor the docks to ensure compliance. The Marina has the right to vary the mooring layout at any time by modifying the assignments of berths for needs related to safety, providing, where necessary, the movement of the boats with its own means and personnel, and any agreement in force between the Marina and the user remains unchanged. It is absolutely forbidden to exchange berths between users unless formally authorized by the Marina.
- 12.6 Competitors are reminded that infractions of the above-mentioned safety rules or inappropriate behaviors reported by the Harbormaster or the Coast Guard to the OA may result in action by the jury, with the boat subject to a

- penalty of up to exclusion from the regatta.
12.7 Sailing inside the harbour is forbidden.

13. HAULING OUT, HULL CLEANING AND DIVING RESTRICTIONS

- 13.1 Boats may not be hauled out after 5 September 2026 until the finish of the final race without prior written permission of the Technical Committee.
- 13.2 Independent swimming/diving inside the harbour is forbidden. Only the Harbour Master's divers are authorized to swim/dive inside the harbour, and they can be booked on VHF Channel 9 or by email to:

Only boats with a hard, non-polishing, non-ablating and non-biocidal urethane primer or topcoat on the underwater areas of the hull, when at their regatta berths and after permission by the Marina Office, may get their bottom cleaned by the Harbour Master's divers.
- 13.3 Repairs and replacement of sails, equipment and hull parts damaged during the regatta shall not require a boat to be re-measured until after the regatta is completed. Applications to replace or repair sails must be made to the technical committee on the sail repair/replacement form available at the race office. No repair shall be carried out or replacement made after registration without the written consent of the technical committee.

14. COMPETITOR DRONES

- 14.1 Teams or their representatives shall not fly drones over the Maxi Yacht Rolex Cup shore base or over the race area during training or racing days without complying with local legislation and without prior written approval by the OA.
- 14.2 The approval granted at the sole discretion of the OA may impose limitations on where and when drones may fly.
- 14.3 The risk and responsibility for flying a drone at any time is with the person flying the drone. Images from inside the race area shall be shared with the OA, Race Committee, International Jury or Competitors at reasonable request.

15. PRIZES

- The following trophies and awards will be presented on Saturday, 12 September:
- Trophies for the 1st, 2nd and 3rd place boats of each class and approved sub-classes;
- His Highness the Aga Khan IV Perpetual Trophy
- Commodore Alberini Perpetual Trophy;
- Paolo Massarini ORC Challenge Trophy;
- IMA Trophy for the highest placed IMA Member;
- YCCS Trophy for the highest placed YCCS Member;
- Monohull (Maxi 1) Overall Line Honours Prize for coastal races;
- Additional trophies at OA discretion.

16. AMENDMENTS TO THE NOTICE OF RACE

- 19.2 The responsibility to hold adequate insurance cover for Third Liability and Third-Party Insurance (Property and Persons) is to the owners or the skippers alone.
- 19.3 The OA is not responsible for verifying the status or validity of insurance certificates.
