## NOTICE OF RACE

The Rolex Swan Cup will take place in Porto Cervo from 13 to 19 September 2026 and is organized, under the authority of the Italian Sailing Federation, by the Yacht Club Costa Smeralda (YCCS), in collaboration with ClubSwan Racing and sponsored by Rolex.

[NP] denotes a rule that shall not be grounds for protests by a boat and for which the International Jury may refuse to hold a hearing. This changes RRS 60.1 and 63.2(a)

### 1. RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The latest version of IMS Rule and ORC Rating Systems for all Classes except those racing as One Design Classes.
- 1.3 Italian Sailing Federation Prescriptions, posted on the WS Website [HERE](#), will apply. Italian crews shall be FIV members and have a valid medical certificate, and Italian boats shall have valid FIV authorization to display advertising (if applicable). Foreign competitors must comply with the rules of their national authority.
- 1.4 The latest version of World Sailing Offshore Special Regulations (OSR) Category 4.
  - 1.4.1 For ClubSwan28 and ClubSwan36 only, the latest version of World Sailing - APPENDIX B – Special Regulations for Inshore Racing are in place.
- 1.5 RRS 48.1 does not apply to water used in a water ballast system that is declared and described in a yacht's measurement certificate. This changes RRS 48.1.
- 1.6 The official language is English. If there is a conflict between languages, the English text will take precedence.
- 1.7 The registration nationality of a boat is indicated by the owner of the boat as set out in the entry form. If not indicated, the sail national letters or the owner's nationality will be used.
- 1.8 In the event of a discrepancy between the notice of race (NoR) and sailing instructions (SI), the Sailing Instructions take precedence (changes RRS 63.5 (c) 2).
- 1.9 For Swan One Design - The regatta will be governed by the ClubSwan 50, Swan 45, ClubSwan 43, ClubSwan 42, ClubSwan 36 and ClubSwan 28 Class Rules unless they are amended within this Notice of Race, in accordance with RRS 87
- 1.10 For Swan One Design - The Nation League 2026 scoring system applies
- 1.11 For Swan One Design – Class Rule Crew weight is amended as per The Nations League 2026 scoring system.
- 1.12 For ClubSwan50 Class ONLY - it may be established a "Guest-onboard-day". All ClubSwan 50 teams will be asked to welcome one guest onboard, with the aim of not creating any advantage/disadvantage. It is the sole responsibility of the OA to decide if, given weather condition, to cancel the "Guest-onboard-day". This amends Class Rule C.2.6 limited to the "Guest-onboard-day". Class Rule C.2.6 applies to any other racing days as per Notice #2.

### 2. SAILING INSTRUCTIONS

The SI will be available to competitors upon final registration and published on the Official Notice Board.

### 3. COMMUNICATION

- 3.1 The Official Notice Board will be online here: [ONB](#).
- 3.2 [NP] All boats shall be equipped with a Marine VHF transceiver operating on VHF channels 09, 16, 71, 72.
- 3.3 Communication with competitors will be via the [ONB](#). Courtesy notices may also be sent via WhatsApp or e-mail

when practicable. Each boat shall have at least one device connected to the internet with WhatsApp installed. Additionally, the race committee may make courtesy broadcasts to competitors on VHF. Failure to send or receive courtesy notices or broadcasts will not be grounds for redress. This changes RRS 61.4(b).

3.4 RRS 41 is changed such that for safety purposes boat to boat communication is allowed and encouraged. A dedicated VHF channel shall be used for this purpose and will be announced at the Skippers' Briefing and published in the SI. Boats shall maintain a constant watch on the safety channel when sailing in or near the racing area.

3.5 Except for safety reasons (NoR 3.4) or in case of an emergency, while racing a boat shall not make transmissions of any kind (voice, written, image, data, etc.) and shall not receive communication of any kind that is not available to all boats.

#### **4. ADVERTISING, IDENTIFICATION NUMBERS, SAIL LETTERS AND NUMBERS**

4.1 Advertising shall only be displayed in accordance with World Sailing Advertising Code. For Italian boats only the "Normativa per l'esposizione della pubblicità nelle manifestazioni veliche in Italia" shall apply.

4.2 [DP] Boats will be required to display the following throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race of the regatta:

4.2.1 Sponsor pennant on the backstay or centre back stanchion and a boom sticker (supplied at registration);

4.2.2 Event battle flag, a sponsor pennant on the forestay throughout the same period while moored (supplied at registration);

4.2.3 An identification number to be displayed clearly on both sides of the hull (supplied at registration);

4.2.4 A class flag on the backstay or centre back stanchion (supplied at registration);

4.2.5 The OA may require the installation, at no cost to competitors, of on-board video cameras for the official television production and/or a GPS tracking system.

4.3 Boats intending to display advertising during the regatta shall state in the entry form the nature of such advertising.

4.4 Boats are responsible for informing advertisers and sponsors that no activities advertising any brand will be permitted ashore within the marina area without written consent from the OA prior to the start of the regatta.

4.5 The regatta logo, the Yacht Club Costa Smeralda burgee and all other associated logos shall not be used by any competitor without the prior written permission of YCCS.

4.6 [NP] [DP] All captains are directed to RRS Appendix G, IDENTIFICATION ON SAILS. Your attention is specifically directed to G1.2 (a) (3) "contrasting color to the body of the sail". Boats national letters and sail numbers must contrast with the sail color. If the letters and numbers do not contrast with the sail color, the boat may be scored DSQ without a hearing. This changes RRS A5.1

#### **5. TECHNICAL COMMITTEE, MEASUREMENT, CONTROL AND RATING**

5.1 The Technical Committee will include representatives from the ORC, ClubSwan Racing and Yacht Club Costa Smeralda.

5.2 Measurement checks on boats entered for racing will take place in Porto Cervo Marina on Sunday 13 between 14.00 and 18.00, on Monday 14 between 09.00 and 18.00 and on Tuesday 15 September between 09.00 and 17.00. Sails may need to be transported ashore to a designated area for measurement check. A list of all competing boat's ratings will be posted on the ONB as soon as practical before the skippers briefing.

5.3 Competing boats will be checked at random during the event and may be boarded at any time by the Technical Committee.

#### **6. ELIGIBILITY & CLASSES**

6.1 The regatta is open to all Nautor Swan yachts.

6.2 All competitors are invited to be ClubSwan Active members. Contact ClubSwan Racing (clubswanracing@nautorswan.com) to discover all the benefits you can enjoy through your membership.

6.3 The intent of the OA is to divide the fleet as presented in section 6. There will be an NOR Addendum published after the entry deadline with the final Division and class breaks. It is the intent of the OA to divide the fleet into Groups and Divisions, that will be further divided into classes, based on final entries. Preliminary class breaks will be published on the event web site.

##### **Group 1:**

Division A (Swan Maxi)

Swan 60 and above models (except for Swan Legacy).

Division A will be split into two classes:

- Swan Maxi Class: Maxi boats from Swan 80 and ClubSwan 80 and above (ORC SY Measured Certificate or ORC SY Declared Certificate)
- Swan Mini Maxi Class: boats from Swan 60 to Swan 78 (ORCi or ORC Club Certificate required).

The Maxi and Mini Maxi classes may be divided into sub-classes.

See Annex 2 for the class split criteria applied.

Division B (Swan Legacy)

Division B will be split into three classes:

- Swan designed by Sparkman & Stephens

- Swan designed by Ron Holland
  - Swan Classic by Frers
- ORCi or ORC Club Certificate required.  
The Swan Legacy classes may be divided into sub-classes.  
See Annex 2 for the class split criteria applied.

Division C (Swan Cruiser Racer) Swan 58 and below models (not Swan Legacy). ORCi or ORC Club Certificate required.

Division C will be split into two classes:

- Swan Cruiser Class
- Swan Performance Class

See Annex 2 for the class split criteria applied.

Division D (Swan Pure Cruising) Swan Boats of any LOA in pure cruising configuration as per Criteria specified in Annex 2.

ORC Club Certificate required.

Division D may be splitted in sub-classes based on the final entry list.

## Group 2:

Division E (Swan One Design) Swan with One Design configuration.

The division will be split into six classes, racing in respective One Design Classes / in One Design Grand Prix

- ClubSwan 50 Class
- Swan 45 Class
- ClubSwan 43 Class
- ClubSwan 42 Class
- ClubSwan 36 Class
- ClubSwan 28 Class
- Swan One Design Grand Prix  
A Swan OD Grand Prix Class may be established. Scoring method and parameters will be provided in a Notice.

6.4 The OA, in conjunction with ClubSwan Racing, reserves the right to have more than one class start together. These decisions shall be final and there shall be no claims for request for redress (changing RRS 61.1(a)).

6.5 The OA, in conjunction with ClubSwan Racing, reserves the right to amend the above division and class designations, and start groupings, based on entries received and/or to merge and/or further split classes at its discretion. The decisions of the OA, after the closing of registration at 17.00 on 14 September, shall be final and there shall be no claims for request for redress (changing RRS 61.1(a)).

6.6 The World Sailing Eligibility Code and the Sailors Categorization Code shall apply for Swan OD Classes.

6.7 [NP] Crew lists and World Sailing Sailor IDs for all crew, as well as declarations of alternate, substitute and relief helmsmen shall be submitted to the Class Secretariat no later than 30 August.

6.8 Crew lists for Swan OD Classes will be displayed on the Official Notice Board by 20.00 on Monday, September 14.

6.9 The Classification Protest Time Limit for crew lists will be at 10.00 on 16 September. For CLUBWAN 50 the Classification Protest Time Limit will be on April 5th as per season crew lists published or, just in case of last-minute crew changes, within 5 days from the publication with the major latest deadline of 10:00 on Wednesday, 16 September for the onsite changes.

6.10 The OA will adhere to all current regulations issued by World Sailing that are in effect on the date of the event regarding participants from Russia and Belarus.

## 7. RACING ENTRIES AND FEES

7.1 Entries shall be submitted on the enclosed Entry Form (Annex 1) which shall be completed and returned not later than 10 August, by e-mail to [secretariat@yccs.it](mailto:secretariat@yccs.it)

7.2.5 Division E (Swan One Design)

7.3 The entry fee shall accompany the entry form. The entry fee may be paid by bank transfer or by the “pay link” system as stated on the entry form. If payment is made by bank transfer, a copy of the transfer confirmation is to accompany the entry form.

7.4 The OA reserves the right to accept entries after 10 August, upon payment of an additional late fee (500,00 €) and retains the right to refuse any entries. Confirmation of any entry will be communicated by the OA. No moorings can be assured for late entries.

7.5 Entries that cancel between 31 May and 10 August will be refunded 50% of any entry fee paid.

7.6 There is no refund for entries that cancel after 10 August.

## 8. NON-RACING ENTRIES

8.1 Swan yachts wishing to participate in the social program of the Rolex Swan Cup, without racing can do so by specifying in the Entry Form. The same entry process and entry fee shall apply.

8.2 Non-Racing entries will only need to indicate the number of people attending the social activities on the Entry Form.

## 9. MOORINGS

9.1 Moorings at Porto Cervo Marina are included in the entry fee. The entry fee includes moorings from 12.00 on Sunday 13 September to 12.00 on Sunday 20 September, provided that the completed entry form and fee are received by the YCCS before 10 August.

9.2 The cost of electricity, water charges, tenders and additional time frames are not included in the entry fee and must be paid directly to the marina office. The mooring place for any additional period (before and/or after the event) may be at Porto Cervo Marina or East Dock (Porto Vecchio) and different from the mooring place assigned during the event. Assignment of moorings will be based on availability of moorings and the characteristics of the boats.

9.3 To reserve moorings prior and after the times and dates indicated in section 9.1 and for tenders/support boats, submit the mooring requirement to [e.pileri@marinadiportocervo.com](mailto:e.pileri@marinadiportocervo.com) c/c [info@marinadiportocervo.com](mailto:info@marinadiportocervo.com) / [secretariat@yccs.it](mailto:secretariat@yccs.it). 9.4 [DP] Local regulations require that all yachts must inform the Harbourmaster’s Office by radio on VHF Channel 9 when they first arrive in Porto Cervo and each time they leave or enter the harbour. When berthed, it is mandatory for all participants to visit the Harbourmaster’s Office to finalize their registration. Participants should consult the Harbour Safety Regulation at the following link: [www.marinadiportocervo.com/regolamento/](http://www.marinadiportocervo.com/regolamento/)

9.5 [DP] All competitors are required by the Harbour Safety Regulations to keep the marina docks in order and provide appropriate space for others moored on the same dock. Sails and dock boxes shall be kept in the immediate vicinity of the assigned mooring place. The Harbourmaster and the Coast Guard will monitor the docks to ensure compliance. The Marina has the right to vary the mooring layout at any time by modifying the assignments of berths for needs related to safety, providing, where necessary, the movement of the boats with its own means and personnel, any agreement in force between the Marina and the User remains unchanged. It is absolutely forbidden to exchange berths between Users unless formally authorized by the Marina.

9.6 [DP] Competitors are reminded that infractions to the above-mentioned safety rules or inappropriate behaviours reported to the OA by the Harbourmaster or the Coast Guard may lead to discretionary penalties by the Jury or exclusion from the regatta. Breaches of these regulations and requirements are not grounds for protests by boats. This changes RRS 60.1.

9.7 [DP] Sailing inside the harbour is forbidden.

## 10. HAULING OUT, HULL CLEANING AND DIVING RESTRICTIONS

10.1 Boats shall not be hauled out during the regatta except with the prior written permission of the OA.

10.2 Independent swimming/diving inside the harbour is forbidden. Only the Harbour master’s divers are authorised to swim/dive inside the harbour and they can be booked on VHF Channel 9 or by email to:

Only boats with a hard, non- polishing or non-ablating and non-biocidal urethane primer or topcoat on the underwater areas of the hull, when at their regatta berths and with permission by the Marina Office, may get their bottom cleaned by the Harbour master's divers.

10.3 [DP] Repairs and replacement of sails, equipment and hull parts damaged during a regatta shall not cause a boat to be re-measured until after the regatta is completed. Applications to replace or repair sails must be made to the OA on the sail repair/replacement form available at the race office. No repair shall be carried out or replacement made after registration without the written consent of the technical committee.

## 11. COMPETITOR DRONES

11.1 [DP] Teams or their representatives shall not fly drones over the Rolex Swan Cup shore base or over the race area during training or racing days without complying with local legislation and without prior written approval by the OA.

11.2 [DP] The approval granted at the sole discretion of the OA may impose limitations on where and when drones may fly.

11.3 [DP] The risk and responsibility for flying a drone at any time is with the person flying the drone. Images from inside the race area shall be shared with the OA, race committee, jury or competitors at reasonable request.

## 12. REGISTRATION

12.1 Registration shall be completed with the OA by 17.00 on 14 September and the official entry list will be published on the YCCS web site – [www.yccs.com](http://www.yccs.com)

The following documents will be required at registration:

(a) Acceptance of the NoR, Disclaimer of Liability, Photography and TV rights consent and third party liability insurance as set out in the Entry Form.

(b) A declaration accepting the waiver of rights that each boat representative will be required to sign accepting this disclaimer of liability.

(c) **For Italian competitors/crews/boats only:**

- FIV cards and a valid medical certification.

- Valid FIV authorization to display advertising on boat (if present).

(d) Media Release Consent form signed by the boat representative.

(e) All racing entries in Group 1 shall have a valid, 2026 ORC certificate (as per section. 6). Certificates will be issued to the yacht by the rule authority, the Offshore Racing Congress ( [www.orc.org](http://www.orc.org) ). To apply for a certificate and for additional information contact the ORC office at: [swan@orc.org](mailto:swan@orc.org) .

All racing entries in Group 2 shall have a valid 2026 One Design certificate. Changes to rating certificates after 14 September will not be permitted unless prescribed and approved by the Technical Committee.

(f) Foreign competitors, crew, boat must comply with the rules of their national authority.

(g) As part of the registration process, the OA requests from each entry a declaration of the boat's insurance Company. (see NoR 22).

(h) Support boats shall register on the dedicated section of the entry form and collect the support boat identification flag at the race office during registration on Sunday 13 September. The support boat identification flag shall be displayed throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race of the regatta. Support boats must also comply with NoR 22.

12.2 <spare>

12.3 Competitors must be at least 12 years old on the first race of the event; crew members between 12 and 18 years old shall deliver at registration a disclaimer signed by a parent or guardian (the Parent Guardian Declaration form will be available on the YCCS website).

12.4 Boats not complying with the requirements of NoR 12 are not eligible for the event.

## 13. REGATTA SCHEDULE

13.1 The Schedule of races will be as follows:

13.2 No race will be started after 15.00 on Saturday 19<sup>th</sup> September.

13.3 The OA and/or the race committee reserve the right to modify the program for weather conditions or any other reason.

#### 14. SCORING

14.1 The low points scoring system of RRS Appendix A will apply, including the following changes:

14.1.1 One race is required to constitute a series.

14.1.2 For Group 1 (Division A,B,C,D) four races are scheduled. No discard will apply.

14.1.3 For Group 2 (Swan One Design): When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

14.1.4 For Group 2 (Swan One Design): When 5 races or more have been completed, a boat's series score will be the total of her race scores excluding her worst score.

#### 15. PENALTY SYSTEM

In accordance with RRS 44 a boat that may have broken a rule of part 2 while racing may take a penalty, but RRS 44.1 is altered such that the penalty is a One-Turn Penalty.

#### 16. PROTESTS & INTERNATIONAL JURY

16.1 Protests will be heard by an International Jury whose rulings shall be final.

16.2 For ClubSwan 50, ClubSwan 28 Appendix UF may apply.

#### 17. RACING AREA & COURSES

17.1 The racing area will be in Northeastern Sardinian waters.

17.2 For boats racing in Group 1, the courses will be coastal courses along the coast and among the islands in the vicinity of Porto Cervo. Boats sailing in Group 2 will sail both coastal (for eligible classes) and also W/L courses.

#### 18. SECURITY & ACCESS

18.1 A regatta wristband will be necessary to use the facilities within the regatta village and also for access to all regatta social events. This wristband is not transferable and will be provided by the OA at registration.

18.2 Each boat will be allocated a designated number of wristbands as part of the entry fee based on the crew list submitted for each boat and for the non-racing entries based on the crew number section of the entry form.

#### 19. AMENDMENTS TO THE NOTICE OF RACE

The OA reserves the right to amend the NoR. Any amendments prior to 13 September will be posted on the Online ONB and emailed to owners whose entries have been accepted. Amendments to the NoR from September 13 will be posted on the online ONB.

#### 20. DISCLAIMER OF LIABILITY

20.1 Competitors agree to be bound by the World Sailing RRS 2024/2028, this NoR and the SI. Competitors agree that the sole and inescapable responsibility for the nautical qualities of any boat participating in the Rolex Swan Cup 2026, including her rigging, safety equipment on board and the competence, behaviour, and dress of her crew, is that of the Owner/Charterer of the boat. Competitors also agree to take full responsibility for all damages whatsoever caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, and hereby relieve from any responsibility, and agree to indemnify on a full indemnity basis and hold harmless, the OA, ClubSwan Racing and Nautor Swan, its servants, agents, and sponsors (in particular but not limited to ROLEX and affiliated companies) and their representatives in respect of any claim arising here from.

20.2 Competitors shall apply RRS Part 1 **Fundamental Rule 3: " The responsibility for a boat's decision to participate in a race or to continue racing is hers alone "**.

20.3 In summary, competitors agree that the OA, ClubSwan Racing and Nautor Swan, its servants, agents, and sponsors (in particular but not limited to ROLEX and affiliated companies) and their representatives have no responsibility for loss of life or injury to members or others, or for the loss of, or damage to any vessel or property.

20.4 As part of the registration process, the boat representative will be required to sign a declaration accepting this disclaimer of liability.

20.5 By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent injury or death by drowning, trauma, hypothermia, or other causes.

20.6 Competitors participate in the event entirely at their own risk. The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during or after the event. General conditions as stated in detail on the entry form.

20.7 The participants are aware that the sailing activity falls within those governed by article 2050 of the Italian Civil Code therefore all Italian participants must have a valid FIV membership, included medical validation, that guarantees accident coverage, including death and permanent disability.

20.8 Not Italian competitors must comply with the requirements of their MNA and be in possession of accident coverage, including death and permanent disability as per current regulations.

20.9 [DP] Environmental responsibility: It is recalled the Basic Principle which states: "Participants are encouraged to minimize any adverse environmental impact of the sport of sailing", it is recommended that care be taken to protect the environment at all times during and after the event. Especially attention is drawn to RRS 47 -TRASH DISPOSAL- which states: "Competitors and support persons shall not intentionally put trash in the water. This rule applies at all times while afloat. The penalty for a breach of this rule may be less than disqualification".

## 21. DATA PROTECTION

22.2 The responsibility to hold adequate insurance cover for Third Liability and Third-Party Insurance (Property and Persons) is to the owners or the skippers alone.

22.3 The OA is not responsible for verifying the status, suitability or validity of a boat's insurance.

- Series trophies for the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> boat in each class.

- The Swan Cup Trophy will be awarded jointly to the winners of the classes and will be held and displayed by YCCS. The Swan Cup Trophy will remain the official and recognized symbol of the event.

- For Divisions A, B and C: The Highland Fling Challenge Trophy will be presented to the top scoring owner driver in the overall results. All competitors wishing to compete for this trophy shall register at the race office before the start of the first race.

- For the Swan S&S Classic Class: The "Rod Stephens Swan Challenge Trophy" will be awarded to the best-placed boat complying with criteria listed in NoR Annex 2.

- For all Classes: daily prizes will be awarded at the discretion of the OA.

A complete list of trophies to be presented during the Rolex Swan Cup will be published on the ONB.

- For Swan Ron Holland Sub-classes (if any) will be defined in relation of the registered boats. Parameters to be announced in a dedicated Notice.
- For Swan Classic by Frers Association members (<https://swanclassicbyfrers.org>) the subclasses are defined as follows:
  - Swan Classic by Frers Up to 51
  - Swan Classic by Frers Above 53

### **DIVISION C (Swan Cruiser Racer)**

Swan 58 and below models (not Swan Legacy). ORCi or ORC Club Certificate required.

Classes in Division C (Swan Cruiser Racer) will be defined by the Dynamic Allowance (DA defined below)\* according to the ORC rule 103.2:

### **Division D (Swan Pure Cruising)**

Division D (Swan Pure Cruising) Swan Boats of any LOA in pure cruising configuration as per following Criteria:

- ORC Club Certificate only
- Furling headsail on forestay, not changeable during the week
- Headsails / Spinnaker permitted. In some meteo conditions their use may be forbidden by the OA
- Boats in their complete cruising mode setup (no upholstery removal, no interior furnitures -like chairs, tables, etc-removal)
- Spray hood must remain on board, either installed or in their storage position. Bimini can be removed.
- Tender and its motor can be removed.
- Appendages must comply with the original Nautor design (no modifications allowed)

Admission to this category will require a self-declaration of compliance with the above criteria and will be subject to continuous evaluation throughout the event.

Courses for this class will be selected in keeping with the spirit of enjoyable sailing for Swan cruising yachts.

Further Sub-classes (if any) will be defined in relation of the registered boats. Parameters to be announced in a dedicated Notice.

\*Dynamic Allowance (DA) is a credit representing the dynamic behavior of a boat taking into account performance in unsteady states (i.e. while tacking) calculated on the basis of: Upwind Sail Area/Volume ratio, Upwind Sail Area/Wetted Surface ratio, Downwind Sail Area/Volume ratio, Downwind Sail Area/Wetted Surface ratio and Length/Volume ratio. DA is applied to the ratings of all Cruiser/Racers, as well as any Performance boats with a Series Date older than 30 years. All yachts have the Dynamic Allowance shown on their ORC Certificate.
