Coastal Courses for Superyacht Classes A & B.
Windward / Leeward courses for the Wally Class.

The race committee will again have Class A yachts start before Class B yachts, with slower rated yachts starting before faster rated yachts in class. The priority is to minimize class mixing and this starting philosophy accomplishes that.

NOTICE TO COMPETITORS No.6

The International Jury's responses to questions raised on the Appendix SY at the Q & A following the Skipper's Briefing.

Question 1

When RRS Appendix SY applies to a Wally because she is within 80 metres of a Superyacht, and also applies to another Wally because that Wally is also within 80 metres of a Superyacht, does Appendix SY apply between the two Wallys?

Answer 1

No. Appendix SY applies between the Wallys and the Superyacht but not between the Wallys.

Question 2

When RRS Appendix SY applies to a Wally because she is within 80 metres of a Superyacht, and does not apply to another Wally because that Wally is not within 80 metres of a Superyacht, does Appendix SY apply between the two Wallys?

Answer 2

No. Appendix SY applies between the Wally within the 80 metres and the Superyacht but not between the two Wallys.

NOTICE TO COMPETITORS No.5

1. Delete Notice to Competitors N.1 and replace with this notice.

2. The International Jury will interpret 'meet' in the introduction to the Sailing Instructions as follows:
 - a) When a Wally yacht and Superyacht come within 80 metres of each other RRS Appendix SY applies to the Wally (as well as to the Superyacht). When they become more than 80 metres apart Appendix SY no longer applies to the Wally;

and
 - b) When a Wally yacht and a Superyacht are both required to leave a *mark* on the same side and any part of one of their hulls is within a distance of 300 metres of the *mark* Appendix SY applies to the Wally and the *zone* for both boats with respect to each other is therefore in accordance with Appendix SY (i.e. it is 300 metres).

Additional Notes:

- a) All competitors are reminded that monitoring the VHF Safety Channel and responding promptly to a hail is mandatory (SY 2.5).
- b) Wally yachts are encouraged to advise other boats by radio on the safety channel when Appendix SY applies to them and also when it no longer applies.
- c) Wallys that are not required to comply with Appendix SY are requested to give Wallys that are required to comply with the appendix *room* and *mark-room* to do so.
- d) Following the Skipper's Briefing, the International Jury will have a Question & Answer session on the Appendix SY and mixed fleet racing.

The Superyacht fleet will have a staggered start racing format with 2 minute intervals between yachts in class. The class A yachts will start before class B yachts with the scheduled starting times below. The race committee will broadcast the scoring option (Time-on-Time or Time-on-Distance) prior to the warning signal for the first yacht to start:

Notice to Competitors N. 1

From: International Jury

The 2016 Loro Piana Superyacht Regatta has entries in the Superyacht fleet as well as entries in the Wally Class. For the boats in the Superyacht-Fleet RRS App. SY applies, while for the Wally class the standard RRS applies. Especially members of the afterguard of a Wally are strongly encouraged to study the RRS App. SY very carefully. In case of questions don't hesitate to contact the International Jury at any time.

When boats of the different fleets meet, RRS App. SY applies.

Basically there are some issues:

1. The Wally is right of way
Superyacht shall take action to keep clear, which includes the 40m minimum distance.
2. Superyacht is right of way
Wally shall take action to keep clear, which includes the 40m minimum distance.
3. Mark roundings
Mark room includes the 40m separation between a Wally and a Superyacht. Be aware that the zone for boats in the Superyacht fleet is 300m.
Consequences:
 - a) A Superyacht reaches her zone (300m) and is clear ahead of a Wally or overlapped with her: RRS 18 starts to apply
 - b) A Wally approaches a mark and is outside of her zone (3 hull length), but closer than 300m of the mark. She is clear ahead of or overlapped with a Superyacht, when this yacht reaches her zone (300m). At this moment RRS 18 starts to apply and the Wally will be regarded as to have reached the zone first.

Note:

In case a Wally follows her obligations with regard to a Superyacht and in the same time she cannot follow her obligations in terms of another Wally, then her obligations acc. to App. SY will prevail and the other Wally shall act accordingly.

Q&A

Question1:

A large rock is submerged one metre below the surface of the water. Is this an obstruction?

Answer 1:

An obstruction can be above the surface of the water or below the surface of the water. The submerged rock is an obstruction if the boat would need to make a substantial change in course if she was one boat length from it.
