Paragraph 2 - Rules

Add NoR 2.9: The Classes Clubswan 36, Clubswan42 and Clubswan50 will use Appendix UF Umpired Fleet Racing Clubswan Edition version September 2021

Add NoR 2.10: For ClubSwan 36 - the World Sailing Offshore Special Regulations Appendix B For Inshore Racing, subject to possible amendments by class rules.

Paragraph 5 – Eligibility & Classes

NoR 5.3 - In Class A - modify to read:

Class A MaxiBoats with LOA of 24.09 metres and above (ORCi Certificate)Class A1 Mini MaxiBoats with LOA between 18.29 and 24.08 metres (ORCi Certificate).

Rationale: The OA, in conjunction with Nautor's Swan and the ORC, has established new parameters for the Swan Maxi class to achieve more similar performance characteristics in that class.

Add NoR 5.9: In accordance with the decision made by World Sailing to suspend participation of Russian and Belarusian competitors, the following are not eligible to take part in this regatta:

- (a) Competitors with Russian or Belorussian passport or representing these countries;
- (b) Boats whose owner or person in charge is a national from Russia or Belarus; or
- (c) Boats registered in Russia or Belarus or with a sail number from these countries.

Paragraph 10 – Radio Communications and Electronic Equipment

Add 10.5: Communication with competitors will be through the online <u>ONB</u>. Additionally, e-mails and/or WhatsApp messages will be used. Additionally, on the water, the race committee will make courtesy broadcasts to competitors on VHF. It is recommended that each boat shall have at least two devices connected to the internet with WhatsApp installed.

Paragraph 12 – Registration

Whenever mentioned in Paragraph 12, delete and replace 7 September with 12 September.

Add NoR 12.5: For ClubSwan50 Class it will be established a "Guest-onboard-day" and it will take place on Sunday 18 September. All ClubSwan 50 teams will be asked to welcome one guest onboard, with the aim of not creating any advantage/disadvantage. It is the sole responsibility of the OA to decide if, given weather condition, to cancel the "Guest-onboard-day". This amends Class Rule C.2.6 limited to the "Guest-onboard-day". Class Rule C.2.6 applies to any other racing days.

Paragraph 20 – Amendments to this Notice of Race

Delete and replace with the following: The Organizing Authority reserves the right to amend this Notice of Race. Any amendments prior to 11 September will be posted on the Online <u>Official Notice Board</u> and emailed to owners whose entries have been accepted. Amendments to this Notice of Race from September 11 will be posted on the online <u>Official Notice Board</u> and sent to each yacht via WhatsApp mobile device or e-mail to the e-mail addresses provided on the Entry Form ("Owner", "boat captain", "Helmsman" and "Tactician" section).
