Competitors also agree to take any and all responsibility for damages caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility the Yacht Club Costa Smeralda, and all persons involved in the organization under whatever qualification and to accept full responsibility for the behaviour and dress of the yacht’s crew, representatives and guests. Competitors are to be acquainted with World Sailing Part 1 Fundamental Rule 4: “The responsibility for a boat’s decision to participate in a race or to continue racing is hers alone”. In any case Competitors agree that the Yacht Club Costa Smeralda, Nautor Holding, the ClubSwan 42, Swan45 & ClubSwan 50 Class Representatives, the sponsors and their agents in particular Rolex SA have no responsibility for loss of life or injury to members or others, or for the loss, or damage to any boat or property. As part of the registration process, each individual participating crew member will be required to sign a declaration accepting this disclaimer of liability.
