The **Zone A** at the Capo Testa is delimited by the coordinates in this table as provided by the decree. In case of a discrepancy between these coordinates and the physical buoy location, both the coordinates and physical buoy shall be regarded as part of the Restricted Area boundary. Any discrepancies between these coordinates and the coordinates on other nautical charts or the physical position of buoys or markers shall not be grounds for a request of redress.
