### SPECIFIC INDICATIONS TO CONTRAST AND CONTAIN THE DIFFUSION OF THE COVID-19 VIRUS ON THE OCCASION OF THE LORO PIANA SUPERYACHT REGATTA.

To ensure a safe and pleasant stay in Porto Cervo during the Loro Piana Superyacht Regatta, we ask for your cooperation and invite you to follow these recommendations.

The YCCS will strive to ensure that your visit remains as special as always and we appreciate your assistance.

In order to ensure a covid-free area during the "Loro Piana Superyacht Regatta" (1-5 June 2021), the Yacht Club Costa Smeralda implements its own safety protocols in line with those of the national and local Health Authorities and the Italian Federation Sailing.

Currently all passengers arriving in Sardinia are required to follow the mandatory registration process at the following link:

Also, at the moment passengers must demonstrate that they have carried out a swab test with a negative result in the 48 hours prior to the first entry or demonstrate to have had the vaccine.

This is what the current disposition imposes but it has already been announced by the Italian Government that after 15<sup>th</sup> of May restrictions in Italy will be surely eased and there will most probably be the cancellation of quarantine to enter Italy from all over Europe. Further updates will be communicated after that date in order to give all the participants the latest information on the correct procedures to enter Sardinia for the Loro Piana Superyacht Regatta.

The YCCS has determined its own procedure in order to assure safety for every participant which is explained below:

- During the access phase, after the demonstration of negativity to the virus, the Organizing Authority of the event provides the distribution to the participants with a bracelet that allows entry in different areas of the event site. This measure is taken in order to widen as much as possible the traceability of the flows of people and in order to guarantee the best safety standards and to contrast against Covid-19 contagion.
- Swabs can be carried out in Porto Cervo in case of necessity, but it is recommended to enter Sardinia with a negative test.
- It is mandatory that each member of the crews participating in the regattas must have to obtain self-certification through the form available on the YCCS Website: [NoR Annex F](#) completed and certifying the successful exhibition of the daily temperature by the athletes onboard their boats, to be delivered daily by email to the Race Office.

#### 1 USE A MASK

It is important to cover your chin, mouth and nose with a mask in all crowded outdoor common areas where it is not possible to respect the 1 metre distance. Wear a mask indoors even where you can maintain the recommended distance.

#### 2 TEMPERATURE

Body temperature will be measured upon entry using a thermal scanner, if this is higher than 37.5°C, access to the structure will be denied.

#### 3 SOCIAL DISTANCING

In the common areas of the structure maintain a distance of at least 1 metre.
